6. **Report on the College of General Studies** (Associate Dean for Undergraduate Studies John Twyning)

CGS Council unanimously approved the following new and expanded policies:

a) Course Substitution Limits.
 This policy goes into effect immediately. CGS Majors and CGS Certificates

Students may appeal for a maximum of two course substitutions for a major or a certificate, and only one course substitution can be applied to the core requirements of a major or certificate. An exception is possible for students who study abroad. Students may apply course substitutions for no more than three courses from an approved study abroad program, and only one of these can be applied to the core requirements of a major or certificate. For students completing minors, course substitutions for

the core requirements are not permissible. Students completing minors can seek one course substitution for elective credit toward the minor, or two courses maximum if these courses are coming from an approved study abroad program. Students who have transferred in half of their credits for a major, certificate or minor cannot seek course substitutions.

No academic policy exists indicating that course waivers are possible. Therefore, any reference to "waivers" in the course substitution appeal documents and website will be removed.

b) Overlapping Credits between majors, certificates and minors within CGS

Courses used for a minor cannot overlap with courses used for a major or a certificate. Students cannot receive a certificate in a program in which they are pursuing their major except for Media and Professional Communications and Administration of Justice majors, who can pursue a certificate outside their area of concentration (major track). Media and Professional Communications and Administration of Justice majors are only allowed to overlap two courses between their major and a certificate.

Natural Science major revision - update

Work on the revisions of the CGS Natural Sciences BS major continues this year. Feedback received from A&S Natural Sciences departments is being reviewed and integrated into the modified program curriculum, and to be presented to CGS Council for consideration by the end of this academic year.

7. **Report from Dietrich School Graduate Council** (Associate Dean for Graduate Studies and Research Holger Hoock)

The Graduate Council has nothing to report at this time.

### 8. Discussion of Gender and Service

# 1. Minutes of the Dietrich School PBC meeting held on January 23, 2019

The minutes of the PBC meeting held on January 23, 2019 were distributed and approved electronically. The minutes were moved, seconded and approved.

### 2. MA TESOL and MQE

(Associate Dean Holger Hoock)

Two new graduate program proposals were discussed. Dean Blee noted that the voting today would be to determine whether or not these proposals should be sent to the Office of the Provost for further consideration. The committee approved both proposals for further consideration.

### 3. Goals 3 and 5 – Global and Community Engagement

The IT Strategic Plan was presented by IT Director Craig Muscato. The plan includes key performance indicators, Chairs Dashboard and online training videos. Budgeting and payroll tools are in development. Dean Blee stressed the importance of providing feedback to the IT team.

#### 4. International undergraduate students

International student retention data was reviewed. Associate Dean Twyning discussed plans for summer programs for new undergraduate international students, before they begin in the Fall term. Students will be charged for the summer courses and progress will be tested at the end of the semester. Expected launch is summer 2020.

### 5. ELI and incoming international students

ELI provides many services for international students, including English proficiency testing and tutoring, courses on the culture of U.S. classrooms, and support for units that serve international students. ELI works with undergraduate peer tutors by providing orientation materials on interactions with non-native English-speaking undergraduates.

### 6. International engagement of graduate students

Currently the graduate student population is 35-38% international. Advising and reporting mechanisms were discussed as means of assessing whether our graduate students are increasing their global engagement through research and travel outside the U.S.

### 7. Global faculty recruiting

The Dietrich School in partnership with UCIS developed a pilot program this year to recruit more international faculty but it was not entirely successful. We will launch a new version next year.

### 8. Community engagement

This agenda item will be discussed at the February 13, 2019 meeting.
